CASH Program Seeks Volunteers Julia Lavarnway

The Southern Tier CASH (Creating Assets Savings and Hope) a free to clients IRS VITA (Volunteer Income Tax Assistance) program, is seeking volunteer tax preparers, receptionists, and screeners for the 2015 tax filing season. Training will begin in November, and tax preparation will begin in late January.

Volunteer tax preparers must possess basic math skills, and some experience doing taxes is helpful but not required. All preparers receive IRS training, and are required to certify with the IRS, attend site orientation, complete practice re-

turns in the tax preparation software and do their first returns under direct supervision. The Volunteer Protection Act of 1997 protects volunteers against liability for returns prepared within their scope of IRS certification.

Volunteer receptionists and screeners greet taxpayers and must have good people skills. Training and orientation will be provided prior to the tax season.

All volunteers may choose the location and hours that are most convenient for them. Daytime, evening, or Saturday shifts are available at most sites. Shifts are typically three to four hours long.

Most information about the Southern Tier CASH program, including volunteer opportunities, is available on the Southern Tier CASH website at www.stcash.org or on the 2-1-1 Helpline site at www.211helpline.org.

Interested volunteers may sign up by following the links above or by emailing CASH@STcash.org.

Southern Tier CASH provides free tax assistance for individuals and families making less than \$60,000, at sites across Chemung, Schuyler and Steuben Counties. Last year, program volunteers com-

pleted returns for more than 5,400 individuals and families, bringing back more than \$7.9 million in refunds to the community.

CASH sponsored, in part, by grants from the Internal Revenue Service Stakeholder Partnerships Education and Communication (SPEC) Division, and United Way of the Southern Tier.

The CASH program is supported by numerous coalition partners throughout the three county area.
