Public Policy Report Pauline Leveen, Chair

Two issues to report, although many others are ongoing. First concerns the legislative branch:

AAUW Action Network urges us and reminds us that bullying and harassment still goes on in our schools. We have had teachers and administrators who have spoken to us about that ongoing problem in some of our local schools. Now, we are urging our members to support a more comprehensive act to make schools free from bullying and harassment in the SAFE SCHOOLS IMPROVEMENT ACT (S403). Many states, districts and schools have policies to prevent and respond to this problem but this Act would fill the gap in FEDERAL education policy. Contact Senators Schumer and Gillibrand to co-sponsor and vote for the SAFE SCHOOLS IMPROVEMENT ACT (S403).

Second concerns the U.S. Supreme Court decisions which will be announced in June amongst others. The Court will be deciding whether the DE-FENSE OF MARRIAGE ACT known as DOMA passed in 1996 is constitutional. Edie Windson legally married her partner Thea Spyer and when Spyer died, Windson inherited
